Fund Objective

This fund aims to provide long term investment returns similar to equity markets but with lower volatility by investing in a broad range of asset classes including equities, bonds, property and alternative assets such as commodities and infrastructure. The fund has a long term return target of LIBOR (cash) plus 3.5% per year over a five to seven year period. This fund is managed by LGIM and their Multi-Asset Team.

What is the dealing cycle?

The fund is forward priced, which means that the member gets the next available price after they invest. The fund has a dealing cycle of T + 0. This means that the money received on day T buys units at the valuation date price applicable at close of business on the same day.

*This is the benchmark that has been selected to compare the performance of the fund. From 21/02/2014 to 24/10/2018 the benchmark consisted of UK Consumer Price Index + 5.0%. From 25/10/2018 to present the benchmark is LIBOR GBP 3 Months + 3.5%. Past performance data includes a period when the fund was provided by Prudential.

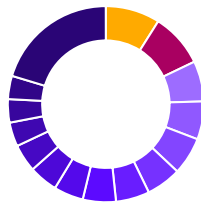

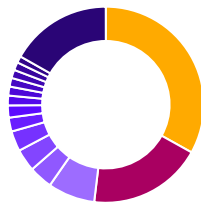
