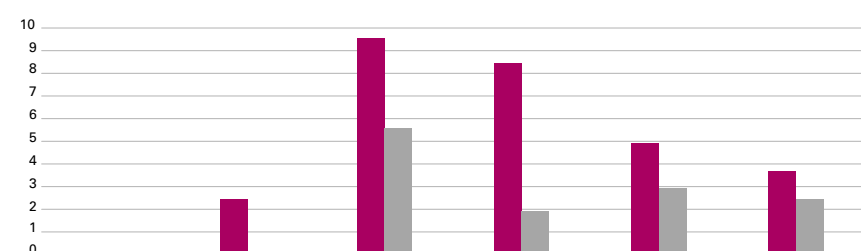

### CAPITAL ALLOCATION (%)

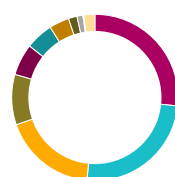

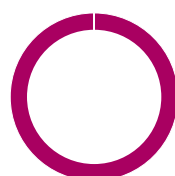

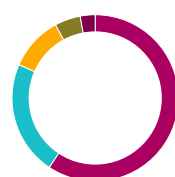
