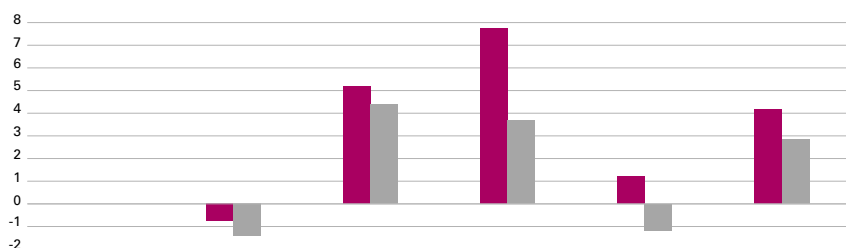

CAPITAL ALLOCATION (%)

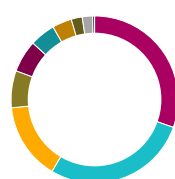

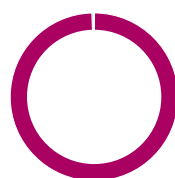

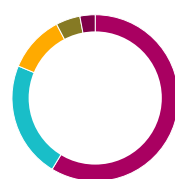
